Allowable Subject Matter

1. Claims 1, 2 and 4-58 are allowed.
2. The following is an examiner's statement of reasons for allowance:

Regarding claim 1, Greiser discloses an antenna comprising a dielectric substrate having a first surface; a first monopole element disposed on the first surface, wherein the first monopole element comprises a conductive region bounded by at least four sides for exhibiting broad band resonance characteristics; and a first ground plane disposed proximate the first monopole element. Greiser, however, fails to further teach a plurality of conductive vias passing through the dielectric substrate for interconnecting the first ground plane and a second ground plane disposed on a second surface of the dielectric substrate.

Claims 2 and 4-21 are allowed for depending on claim 1.

Regarding claims 22 and 51, Greiser teaches an antenna system and method for forming an antenna thereof comprising a dielectric substrate having a first surface; first and second spaced apart monopole elements disposed on the first surface; and a first ground plane disposed proximate the first and second monopole elements. Greiser, however, fails to further teach a first signal feed connected to the first monopole element and a second signal feed connected to the second monopole element.

Claims 23-46 and 58 are allowed for depending on claim 22.

Claims 52-57 are allowed for depending on claim 51.

Reasons for indicating allowable subject matter for claims 47-50 were provided in the previous Office action.
