Re: Release of Security Interest

Reference is made to that certain Amended and Restated Loan and Security Agreement, dated as of October 11, 2013 (as the same may have been amended, restated, or otherwise from time to time, the "Loan Agreement"), by and between SkyCross, Inc. ("Borrower") and NXT Capital, LLC, as agent ("Agent"), and a lender ("Lender"), and Business Development Corporation of American, as a lender (a "Lender" and, collectively with all lenders, the "Lenders"). Further reference is made to a pay-off letter from Agent and Lenders to Borrower, dated June 20, 2014 (the "Pay-Off Letter").

This letter is to memorialize that, pursuant to the terms of the Pay-Off Letter: (i) all indebtedness of Borrower to Agent and Lenders under the Loan Agreement and any other related loan and collateral security documents has been paid and discharged in full; (ii) all unfunded commitments to make credit extensions or financial accommodations to Borrower or any other person under the Loan Agreement have been terminated; and (iii) all security interests and other liens of every type at any time granted to or held by Agent and Lenders as security for such indebtedness of Borrower have been terminated.

Agent and Lenders hereby authorize Borrower (or Borrower's designees), at Borrower's (or Borrower's designees') sole cost and expense, to prepare and file any UCC-3 Financing Statement Amendments or other documents necessary to evidence the termination of Agent's and Lenders' security interests in any of Borrower's property or assets (or that of any third party providing collateral security for the payment and performance of the Obligations). Agent and Lenders shall cooperate with Borrower, at Borrower's sole cost and expense, to execute and delivery any agreements, documents, and other instruments that may be reasonably requested and prepared by Borrower to evidence the termination of Agent's and Lenders' security interest in any of Borrower's property or assets.


