DETAILED ACTION***Drawings***

The drawings are objected to under 37 CFR 1.83(a). The drawings must show every feature of the invention specified in the claims. Therefore, the perforations in the perforated stationary plate can be closed or open and thus restrict or promote air that passes to the organic waste fuel on the moving grate, the organic waste fuel-byproduct between the organic waste fuel on the moving grate and the moving grate is about 1-2 inches thick must be shown or the feature(s) canceled from the claim(s). No new matter should be entered.

Corrected drawing sheets in compliance with 37 CFR 1.121(d) are required in reply to the Office action to avoid abandonment of the application. Any amended replacement drawing sheet should include all of the figures appearing on the immediate prior version of the sheet, even if only one figure is being amended. Specification

The amendment filed 12/3/04 is objected to under 35 U.S.C. 132 because it introduces new matter into the disclosure. 35 U.S.C. 132 states that no amendment shall introduce new matter into the disclosure of the invention. The added material which is not supported by the original disclosure is as follows: The partially closed configuration of paragraph 21 of the specification and figure 2.

Applicant is required to cancel the new matter in the reply to this Office Action.


