DETAILED ACTION

The following is a first action on the merits of application Serial No.11/366,984, filed March 2, 2006. This application is a reissue of U.S. Patent 6,698,567, for which an Inter Partes Reexamination Certificate was issued on December 2, 2008. A communication mailed November 19, 2008 by the Office gave applicant one month to submit an amendment of this reissue application to reflect the changes in the claims based on the concluded reexamination proceeding. Additionally required was a supplemental reissue oath or declaration identifying the error to be corrected in current patent claims as set forth in the reexamination certificate. No response was received.

Information Disclosure Statement

Receipt is acknowledged of the Information Disclosure Statements filed March 2, 2006, December 21, 2007, June 5, 2009, and July 8, 2009. The cited documents have been considered. The references cited have not been applied against the claims since the claims in this reissue application do not reflect the changes resulting from the reexamination proceedings.

Claim Rejections - 35 USC § 112

The following is a quotation of the second paragraph of 35 U.S.C. 112:

The specification shall conclude with one or more claims particularly pointing out and distinctly claiming the subject matter which the applicant regards as his invention.

Claims 1-53 are rejected under 35 U.S.C. 112, second paragraph, as being indefinite for failing to particularly point out and distinctly claim the subject matter which applicant regards as the invention. The claims in this reissue application are not the current patent claims and thus fail to particularly point out and distinctly claim the invention. Columns 1-6 of the Inter Partes Reexamination Certificate show the current patent claims.

Oath/Declaration

The reissue oath/declaration filed with this application is defective because it fails to identify at least one error which is relied upon to support the reissue application. See 37 CFR 1.175(a)(1) and MPEP § 1414. The reissue oath or declaration must specifically point out the error to be corrected in the patent claims, which are the claims set forth in the reexamination certificate.

Rejection under 35 USC 251

Claims 1-53 are rejected as being based upon a defective reissue declaration under 35 U.S.C. 251 as set forth above. See 37 CFR 1.175.

The nature of the defect(s) in the declaration is set forth in the discussion above in this Office action.
