DETAILED ACTION

Allowable Subject Matter

1. The following is a statement of reasons for the indication of allowable subject matter:

Claim 17 is allowable over the art of record because the prior art does not teach a signal separator connected to the conductive element, the signal separator responsive to the radio frequency signal through the conductive element, the signal separator responsive to the control signal, the signal separator supplying the radio frequency signal to a receiving element of the communications device and supplying the control signal to the resonant frequency controller for controlling the tunable elements and in combination with the remaining claimed limitations.

2. Claim 23 is allowable over the art of record because the prior art does not teach a signal separator receiving the radio frequency signal through the first conductive element, the signal separator receiving the control signal through the second conductive element and supplying the radio frequency signal to a receiving element of the communications device through the second conductive element, the signal separator supplying the control signal to the resonant frequency controller for controlling the tunable elements and in combination with the remaining claimed limitations.

3. Claim 32 is allowable over the art of record because the prior art does not teach a signal separator receiving the radio frequency signals through the first conductive element, the signal separator receiving the control signal through the second conductive element and supplying the radio frequency signals to the receiving element through the second conductive element, the signal separator supplying the control signal to the resonant frequency controller for controlling

the tunable elements to receive the desired radio frequency signal and in combination with the remaining claimed limitations.
