Allowable Subject Matter

1. Claims 4-20 are allowed.
2. The following is an examiner's statement of reasons for allowance:

Regarding claim 4, Raguinet et al (US 5,489,913) discloses an antenna comprising a dielectric tubular member; a second conductive material forming an exterior surface of the tubular member; the second conductive material defining a slot therein, the slot having a slot length approximately equal to one-half of a guided wavelength and having a slot width, there being no slot present in the tubular member immediately beneath the slot in the second conductive material, and a feed proximate the slot for establishing currents in the second conductive material when the antenna is in a transmitting mode, the currents perpendicular to the slot length. Raguinet, however, fails to further teach that a width of the opening defined by the first conductive material is less than a quarter wavelength of the guided wavelength.

Reasons for indicating allowable subject matter for claims 5-20 were provided in the previous office action.
