The present application is being examined under the pre-AIA first to invent provisions.

Allowable Subject Matter

Claims 1 and 2-28 are allowed.

The following is an examiner's statement of reasons for allowance:

Claim 1 has been amended with the subject matter of claim 2, which was cited as allowable in the Office Action sent on May 29, 2014.

Claims 16-27 were previously cited as comprising allowable subject matter in the Office Action sent on May 29, 2014.

Upon conclusion of a comprehensive search of the pertinent prior art, the Office indicates that the claims, as amended, are allowable. Regarding independent claim 1, patentability is indicated as existing, at least in part, with the claimed combination of elements and features of: a second balanced antenna provided on the printed circuit board assembly, wherein the second balanced antenna has dipole ends being excitable to an electrical potential of equal magnitude and opposite sign, resulting in an approximately neutral potential at the ground plane, wherein the dipole ends are oriented such that the axis of polarization is approximately normal to the ground plane of the printed circuit assembly.

Regarding independent claims 16 and 28, patentability is indicated as existing, at least in part, with the claimed combination of elements and features of: the second balanced antenna comprises two approximately symmetrical dipole ends positioned approximately equidistant from the printed circuit board assembly on opposite sides of the printed circuit board assembly.
