The present application is being examined under the pre-AIA first to invent provisions.

DETAILED ACTION

The Amendment, filed on September 22, 2014 has been entered and acknowledged by the Examiner.

Cancellation of claims 7-26 and addition of claims 27,28 have been entered.

In view of amendment the objection to Drawing and 35 U.S. C. 112 first and second paragraph rejections have been withdrawn.

Claims 1, 3-6 and 27,28 are pending in the instant application.

Allowable Subject Matter

Claims 1, 3-6, 27 and 28 are allowed over the prior art of records.

The following is an examiner's statement of reasons for allowance:

Regarding claim 1 the prior art of records do not teach or suggest the apparatus for controlling a three-dimensional optical field including the combination of limitations as claimed and particularly the set of zoom elements projecting light onto the first portion to form a first sub-shape on the first portion and onto the second portion to form a second sub-shape on the second portion, the first and the second sub-shapes form a combined light shape when observed along the light axis, and the combined light shape has a contour essentially free from a distortion .

Claims 3-6, 27 and 28 are allowed because of their dependence from claim 1.
