The Examiner objected to the drawings because reference numerals 2, 3, and 4 each are used twice to identify two different elements. A replacement sheet including Figures 1a) and 1b) which has been revised to eliminate the repetitive use of reference number 2, 3, and 4 is submitted herewith. The withdrawal of the objection to the drawings is respectfully requested.
