### **EXAMINER'S AMENDMENT**

The present application is being examined under the pre-AIA first to invent provisions.

### **REASONS FOR ALLOWANCE**

The following is an examiner's statement of reasons for allowance: This case is being passed to issue because a search of the prior art did not reveal a reference or combination of references disclosing a system for delivering cargoes into space, the system including, *inter alia*, suborbital aircrafts to launch cargoes; a satellite solar power station; and at least one container spacecraft having a receiving device, storage tanks, a braking medium container, and an arrangement for separating the cargo and a braking medium, with the cargoes being disposed as at least one of a cloud of dust particles, microcapsules, spheres, containers, bars, wires, or tapes on a movement path of the at least one container spacecraft. A method for delivering cargoes into space utilizing the above elements, whereby the cargoes are captured by the at least one container spacecraft and enter the receiving device and braking medium container of the at least one container spacecraft, also was not found.
